IF A DOG PASSES THE FETCH DOG TEST ON TWO OCCASIONS, THE OWNER MAY APPLY FOR THE AKC FETCH TITLE. UPON APPLICATION WITH AKC, THE FETCH TITLE WILL BE APPLIED TO THE DOG'S RECORD AND WILL APPEAR ON THE DOG'S AKC TITLE RECORD AND NAME. THE TITLE CERTIFICATE WILL BE MAILED TO THE DOG'S PRIMARY OWNER OF RECORD.
